

## Schedule of Membership Dues and Education Fees

#### **Membership Dues**

Age category is determined by the age of the oldest adult in the household as of July 1, 2025.

#### **Rates for Your First Three Years**

- First Year of Membership: New members are invited to contribute at the under-39 or 39-and-above introductory level.
- Second Year of Membership: Members are asked to contribute **50% of the full dues** for their age category.
- Third Year and Beyond: Members contribute **full dues** based on their age category.

Please note: Families with children enrolled in our Religious School are invited to contribute at the full dues level for their age category. This helps sustain the rich learning experiences and vibrant Jewish education that benefit all of our children.

## \*Welcoming the Next Chapter

As members celebrate turning 39, we offer a gradual transition to the new dues category. For the first year in this category, members are invited to contribute 60% of the 39+ dues amount. The following year, we kindly ask for full participation at 100%.

### **Supporting Our Community's Safety**

We ask all members to consider an additional contribution equal to 5% of household membership dues. This helps us address the increasing costs of ensuring a safe and secure environment for all who gather at Temple Israel. Your partnership in this effort is deeply appreciated.

### **Wedding Fee**

For members in their first year of membership contributing at the introductory level and seeking clergy to officiate their wedding, a \$1,000 fee is requested upon setting a wedding date. This supports the ongoing programs and engagement opportunities offered by Temple Israel.

All members are warmly invited to make a gift of appreciation to the Clergy Discretionary Fund in honor of the clergy member who officiates their wedding. Thank you for considering this meaningful gesture.

# Frances Jacobson Early Childhood Center (FJECC) Priority Enrollment & Tuition Discount

Temple Israel members are eligible for priority enrollment at the Frances Jacobson Early Childhood Center (FJECC) and may receive a tuition discount when household membership dues are at or above \$720 for a one-adult household or \$1,440 for a two-adult household.
